ABNA will continue working with sponsors and members of the biobanking community to deliver this event.



### **ISBER Conference Update**

The International Society for Biological and Environmental Repositories Board of Directors has made the difficult decision not to proceed with the 2020 Annual Meeting scheduled for April 14 – 18, 2020.

This decision was made after careful consideration and comprehensive evaluation of currently available information related to the novel coronavirus (COVID-19) pandemic. ISBER would like to thank all of you who have reached out to provide valuable feedback regarding the conference.

As you know, ISBER has been closely monitoring the rapidly increasing domestic and worldwide developments during the last several weeks related to COVID-19. This evidence-based decision was made after a thorough review and discussion of all factors impacting the Annual Meeting, including the U.S. government's enforcement of restrictions on international travelers to enter the U.S.; the imposition of travel restrictions on employees of U.S. government agencies, cancer centers, academic institutions, and pharmaceutical and biotech companies who are the meeting attendees; and the guidance of the CDC, WHO, other federal, state and local public authorities, and infectious disease experts.

It is clear that all of these elements make it impossible to insure the safety of delegates, speakers, presenters of abstracts, and exhibitors. For these reasons, ISBER regretfully announced the cancellation of the meeting.
